1. Introduction and Acceptance

This Privacy Policy ("Policy") governs the manner in which AutoDream, under the laws of the State of California, United States of America, with its principal place of business located at 11950 Erwin St, North Hollywood, CA 91606 (hereinafter referred to as "AutoDream," "we," "us," or "our") collects, processes, stores, protects, discloses, and utilizes personal information and data obtained from users ("User," "you," or "your") of the AutoDream.com website, mobile application, and related services (collectively, the "Platform"). By accessing, browsing, or otherwise utilizing the Platform, you hereby signify your unqualified acceptance of this Policy and consent to the collection, use, and disclosure of your personal data in accordance herewith. Should you not agree to any provision of this Policy, you must immediately cease all use of the Platform.

2. Definitions

For purposes of this Policy, the following terms shall have the meanings ascribed herein:

"Personal Data" or "Personal Information" means any information relating to an identified or identifiable natural person, including but not limited to your full name, residential or mailing address, email address, telephone number, payment information, user credentials, IP address, geolocation data, and any other information that can be directly or indirectly linked to you.

"Processing" means any operation or set of operations performed on Personal Data, whether or not by automated means, including collection, recording, organization, structuring, storage, adaptation, retrieval, consultation, use, disclosure, dissemination, alignment, restriction, erasure, or destruction.

"Cookies" means small text files stored on your device by the Platform to facilitate enhanced functionality, tracking, or user experience.

"User Content" means all information, data, messages, communications, images, listings, and other materials submitted or uploaded by users.

3. Scope of Data Collection and Processing

3.1. Categories of Data Collected:

AutoDream collects, processes, and stores Personal Information that you voluntarily provide during account registration, profile creation, posting of vehicle listings, payment transactions, and communications through the Platform. Such Personal Information may include, but is not limited to, your full legal name, physical address, email address, phone number, payment card or bank account details, government-issued identification data, and any other information you choose to submit.

3.2. Automated Data Collection:

In addition, AutoDream automatically collects certain technical information about your device and usage patterns through cookies, web beacons, IP addresses, device identifiers, browser type, operating system, access times, and referral URLs to enhance Platform functionality, optimize user experience, perform analytics, and prevent fraudulent or malicious activities.

3.3. Purposes of Processing:

We process your Personal Information exclusively for purposes reasonably necessary to: (a) provide, maintain, and improve the Platform and its features; (b) authenticate your identity and grant access to restricted content; (c) facilitate transactions, including billing and payment processing through third-party providers such as Stripe, PayPal, and VTB Bank; (d) communicate with you regarding your account, transactions, and support inquiries; (e) comply with legal and regulatory obligations; (f) protect the rights, property, and safety of AutoDream, its Users, and third parties; and (g) conduct internal analytics, marketing, and business development activities.

3.4. Legal Bases for Processing:

Your Personal Data is processed based on one or more of the following lawful grounds: (i) your explicit consent; (ii) necessity for performance of a contract to which you are a party; (iii) compliance with legal obligations imposed upon AutoDream; and/or (iv) AutoDream's legitimate interests, provided such interests do not override your fundamental rights and freedoms.

4. Age Restriction and Protection of Minors

The Platform is expressly intended for use by persons who have attained the age of majority, which is eighteen (18) years or older, in accordance with applicable jurisdictional law. By utilizing the Platform, you affirm, represent, and warrant that you are at least eighteen (18) years of age. AutoDream does not knowingly collect or solicit personal information from individuals under eighteen (18) years old, and any such data inadvertently collected will be promptly deleted upon discovery. If you believe that we may have retained information of a minor, please contact us immediately so that we may take appropriate corrective action.

5. Data Retention and Deletion

AutoDream retains Personal Information for no longer than necessary to fulfill the purposes for which it was collected, or as required by applicable laws, regulations, or lawful requests from government authorities. Upon termination of your account or at your request, we will endeavor to delete or anonymize your Personal Information, except where retention is necessary for compliance, enforcement of terms, dispute resolution, fraud prevention, or as otherwise mandated by law.

6. Disclosure and Sharing of Personal Data

AutoDream does not sell, trade, or rent your Personal Information to third parties. Disclosure of your data may occur only to trusted service providers who assist in operating the Platform and are contractually bound to maintain confidentiality and data security consistent with this Policy. We may also disclose your information when compelled by law, subpoena, court order, or other legal processes, or to protect our rights, property, or the safety of Users or the public.

7. Cookies and Tracking Technologies

The Platform utilizes cookies and similar tracking technologies for operational, analytical, and advertising purposes. These technologies collect information about your browsing behavior and preferences to facilitate a customized user experience. Users may adjust browser settings to refuse cookies; however, this may impair access to certain Platform features.

8. Security Measures and Limitations

AutoDream employs commercially reasonable technical, administrative, and physical safeguards designed to protect Personal Information against unauthorized access, disclosure, alteration, or destruction. Notwithstanding these measures, you acknowledge and accept that no method of transmission or storage is entirely secure, and we disclaim any liability for unauthorized access or breaches beyond our reasonable control.

9. User Rights and Control

Subject to applicable law, you retain certain rights regarding your Personal Information, including the right to access, rectify, delete, restrict processing, object to processing, and data portability. You may exercise such rights by contacting AutoDream at the contact details provided below. We reserve the right to verify your identity before processing such requests.

10. International Transfers

Personal Information collected through the Platform may be transferred to, processed, and stored in jurisdictions outside your country of residence, including the United States, which may not offer the same level of data protection. By using the Platform, you consent to such transfers and processing.

11. Limitation of Liability

To the maximum extent permitted by applicable law, Auto Dream and its affiliates, officers, directors, employees, agents, and service providers disclaim all liability, whether in contract, tort, negligence, strict liability, or otherwise, for any direct, indirect, incidental, consequential, punitive, exemplary, or special damages arising from or related to the collection, use, processing, storage, or disclosure of your personal information or your use of the platform, including but not limited to any loss of profits, loss of data, loss of business opportunities, or damages resulting from data breaches, unauthorized access, or errors in data.

12. Modifications to This Policy

AutoDream reserves the right to amend, update, or revise this Privacy Policy at any time and for any reason, effective immediately upon posting on the Platform. Continued use of the Platform after such changes constitutes acceptance thereof. You are encouraged to periodically review this Policy.
